
## Criteria 6.1.2 Decentralization & Participative Management

### DECENTRALIZATION - An Overview

Sandra Shroff College of Nursing, Vapi, has more than 22 committees that oversee various aspects essential for the smooth functioning of the college. These committees address areas such as academics, administration, cultural development, social involvement, and inclusion. All convenors report to the principal on a need-based basis. Financial matters, especially those involving significant expenditure, are discussed in advance with the Treasurer, who is a member of both the SSCN Governing Body and the Trust Governing Body.

Faculty members are actively involved in all student bodies on campus, including both permanent and temporary committees. Faculty are rotated among committees to prevent stagnation and avoid the development of a sense of proprietorship.

### 1. Strategic Level


