NOTIFICATION

In exercise of the powers conferred upon by the **Statute 25** of the Gujarat Public Universities Uniform Statutes 2024 regarding nomination of members in the **Board of Studies** of Veer Narmad South Gujarat University, Surat, the Hon'ble Vice Chancellor has nominated following members in the **Board of Studies - Nursing** under the **Faculty of Medicine**.
