ANTI RAGGING COMMITTEE

WHAT IS RAGGING?

Ragging is any physical, verbal or mental abuse committed by one student against another student belonging to an educational institute. The seniority of the student who rags or is ragged does not matter.

Ragging is a crime and it can happen for any reason. Ragging has been known to happen on the basis of appearance or color of the skin, race, religion, caste, ethnicity, sexual orientation, appearance, nationality, regional origins, spoken language, place of birth, place of residence or economic background. It can take many different forms. For example, bullying a student into doing assignments or excluding a student from campus activities. The law punishes different forms of ragging against students including psychological harm, physical abuse, etc.

INC REGULATIONS ON RAGGING:-

INC has made it very clear that all INC approved institutions should strictly follow the directions of Hon'ble Supreme Court of India & Raghavan Committee recommendations without exception. It is clearly mentioned in the regulation that Ragging is totally banned & anyone found guilty of ragging and/or abetting ragging is liable to be punished.

PUNISHMENTS TO THE STUDENTS:-

- Every single incident of ragging a First Information Report (FIR) must be filled without exception by the Institutional authority with the local police authorities.
- Anti-ragging committee of the Institution shall take an appropriate decision, with regard to punishment.
- Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the Institution level shall be anyone or any combination of the following:-
 - Cancellation of admission.
 - Suspension from attending classes.
 - Withholding/withdrawing scholarship/fellowship and other benefits.

- Debarring from appearing in any test/examination or other evaluation process.
- Withholding results.
- Suspension/expulsion from the hostel.
- Debarring from representing the Institution in any regional, national or international meet, tournament or youth festival etc.
- Restriction from the Institution for period ragging from 1 to 4 semesters
- Expulsion from the Institution and consequent debarring from admission to any other Institution.
- Fine upto Rs. 2,00,000/- (Rupees Two Lakh only)
- Any other punishment as decided by the competent authority.

INSTRUCTIONS TO STUDENTS:-


RAGGING IS BANNED, there of all the students of SSCN are advised to refrain from all such activities which are directly or indirectly related to ragging. A wholchearted coordination with the members of Anti-ragging Committee will be appreciated.

- All students will be bound to obey the appropriate punishments, if found guilty, without any prior indications whatsoever.
- All students should intimate the incidents of ragging, if any, to the officials of Anti Ragging Committee Members number immediately after witnessing the matter.

It is mandatory for all students to fill in an Anti-Ragging Undertaking online soon after the admission in the College

- Debarred from examination
- Denied admission to any college/ institution
